Visa Waiver Program for Traveling to the U.S.

You may be eligible to enter the United States without a visa if you are a citizen of one of the following countries:

^{*}Please note Canadian citizens do not require a visa stamp to enter the United States.

As of October 26, 2004, all travelers entering the United States under the Visa Waiver Program must have a **machine-readable passport**. Any traveler without a machine-readable passport will be required to obtain a visa before coming to the United States. A machine-readable passport contains two typeface lines printed at the bottom of the biographical page. (See the example below).
